

Objectives and activities

"rites of passage for major life events from birth to death and everything in between"

We set up A Quiet Revolution to support people to find creative and meaningful ways to mark life's big moment.

Our Constitution captures our purpose as:

- 1) the advancement of the philosophical belief and the promotion of the values of Humanism
- 2) the relief of those in need by reason of age, ill-health, disability, financial hardship or other disadvantage.

We aim to achieve the first purpose by composing and conducting rites of passage to support individuals, couples, families and their extended family – significant others, friends, neighbours, professional and volunteer supporters and communities of interest – at key life stages. We promote positive attitudes, encourage open conversations and carry out legal ceremonies and rites of passage for major life events from birth to death and everything in between.

To achieve the second purpose, we are building funds to eventually be able to offer financial support for individuals, couples and families who can't afford ceremonies. Our intention is to cover the costs of the celebrant and offer the service free to those in need.

Structure, governance and management

Type of governing document

Our charity is governed by a Constitution. This is available on request.

Trustee recruitment and appointment

During the course of the year, Hazel Fraser retired due to ill health.

We took the opportunity to think about succession planning and recruited two Trustees to build capacity.

Jacquie Winning is a third sector leader with extensive experience of supporting disadvantaged individuals and communities in the context of vision and hearing loss, homelessness and welfare. She is Manager of the Sensory Centre in Forth Valley. She works with diverse clients, offering support and nurturing to improve the quality of life. She is skilled in coaching, management, leadership, project management and customer service. She has a Master of Arts (MA) in English Language and Literature from the University of Glasgow.

Maggie O'Hara Watt is a recently retired health professional with 40 years' experience of providing care to people unable to access routine services due to health, behavioural, communication and other difficulties. Maggie contributed to the development of Forth Valley Dignity and Respect at work policy.

Both share A Quiet Revolution's Humanist approach to the promotion of equality and diversity and the compassionate support of people who wish to shape and create their own rites of passage and life experiences.

Achievements and performance



2017-18 was AQR's first full year of activity.



AQR set out in 2016-17 with 3 associated celebrants working independently as AQR affiliates to support individuals, couples and families to create meaningful Humanist ceremonies. For the year to end June 2018, most of the ceremonies were carried out by Barbara Chalmers, Irene Edgar and James Oakley – the original associates.

The team attended two wedding fairs in Glasgow to extend their reach. Over the course of the year, it became clear there was more demand than the 3 could service. In May 2018, four new fully trained celebrants joined as affiliates. Professional film and photography was commissioned for the new website to enable clients to see and hear celebrants in action to help them make informed choices.

The General Registrar's Office (GRO) would only agree in advance to approve that two further celebrants could join the team. Others will be considered case by case. This limit compromises the charity's ability to grow capacity to support all those who are turning to Humanist celebrants to conduct legal weddings. This will be explored further with the GRO in coming years.

The team – Trustees and celebrants – explored ideas to support the charity's second purpose, supporting people in need. It was agreed these would be developed in 2018-19 when funds grew.

Humanist ceremonies

The team offers to create ceremonies for weddings (same sex and opposite sex), vow renewal, baby namings and funerals. Over the course of the year they conducted ceremonies across Scotland from Perthshire to Galloway in art centres, old churches, castles and on the banks of lochs and in back gardens.



Barbara conducted the first wedding ever held in Perth Concert Hall, one in Glasgow's City Hall/Old Fruitmarket, one in Cottiers and one on the banks of Loch Lomond. She conducted two funerals at Linn Crematorium.

James conducted 12 weddings across west and central Scotland – Glasgow, Barrhead, Kilsyth, Stirling, Dalmeny, Dalhousie, Luss, Biggar and Busby.

Irene conducted two weddings – one in Galloway and one in Inchyra and a renewal of vows ceremony in Loch Lomond.

Jude did her first wedding in Glasgow's House for an Art Lover.

Kenny conducted his first wedding in Aberfoyle.

The diversity of the ceremony location is a great reflection on the diversity of the couples. It is no understatement to say all those ceremonies were so distinct to those couples. Every one was a beautiful and unique celebration of the couple, their love and what has meaning for them. For every couple the journey of creating their ceremony was more fulfilling and enlightening than they had realised it would be. It was an opportunity to really consider what they wanted from the future and how to express their feelings in the here and now.

Every event is designed to be memorable and meaningful for those seeking support. It is also part of the personal learning journey for the celebrant as they grow skills and capacity to meet the needs of those they support, helping guide them through momentous life events.

Financial review

At this stage in our young charity's life, there are no fixed costs. Celebrants are self-employed. Celebrants' insurance covers Trustees. Celebrants maintain a website and blog and bear the costs of advertising for celebrant services. Trustees are volunteers. There is a volunteer Administrator. Individuals, couples and families who choose our celebrants to support important life stages are entitled to free membership of A Quiet Revolution. Each is invited to make a donation to the charity at the time of seeking Humanist support. Donations amounted to £1,357 over the course of the year bringing balances to £1,507 at end June 2018.

Statement of the charity's policy on reserves

The charity currently operates with zero costs. Growth is planned to happen organically among the members, volunteers and celebrants who currently make donations – financially, energetically and in kind. There are no restricted funds. The current balance of £1,507 is available to support the growth of the charity and to make donations to support the charity's purposes.

Donated facilities and services

In support of the second purpose of the charity – to support people in need – in the longer term, the charity intends to make donations from its funds. In this first full year, while we were assessing how we operate, no donations were made in order to ensure there were no unforeseen expenses or risk to the sustainability of the charity.

Future plans

There was more wedding than funeral activity in this first year. It is likely that in future, celebrants may offer more funeral services.



Related to that, from year two on, AQR will be in a position to offer donations itself. It is likely that these donations will enable people who can't afford funerals to have the services of a celebrant free to create the ceremony they want for themselves or their significant others. This will help the charity achieve its purpose of supporting disadvantaged people.
